Nebraska employs more than 96,605 in the manufacturing industry. Manufacturers account for 12.5 percent of the total output in the state, employing 9.6 percent of the workforce. There are more than 1,888 manufacturing establishments in Nebraska. Total output from manufacturing was \$12.5 billion in Nebraska in 2012.




Education

- There are currently 14 community colleges that can assist industries with setting up training programs based on mutually agreeable cost-sharing arrangements.
- There are currently 22 universities and colleges that offer a variety of programs statewide.
- With more than 50,000 students, the University of Nebraska system has four universities and one technical college producing more than 10,600 graduates in 2013.
- Top 10 Science and Engineering Doctorates conferred per 1,000 S&E doctorate holders
- Top 10 Bachelor's degrees conferred per 1,000 individuals 18-24 years old
- Top 15 Postsecondary degree holders among individuals 25-44 years old



Business Logistics

Nebraska's central location, combined with the transportation advantages of a major river, strong rail and truck services, air service equal to other Midwest states, and a major national interstate highway crossing the entire state, gives Nebraska access to all major U.S. and overseas markets.

Nebraska employs more people in the trucking industry than anywhere else in the nation, as a percentage of total employment. The state had the highest job growth in the nation for the transportation, distribution, warehousing and logistics sector in 2013.

- I-80 and connecting interstate roadways offer easy, direct transportation to major markets including Denver, Salt Lake City, Des Moines, Chicago, and Detroit.
- Nebraska is in the center of the NAFTA trade corridor.
- Nebraska competes globally. Total exports totaled \$7.5 billion in 2011, representing a 31% increase from 2010, and a 19.4% increase from 2009.
- Nebraska has two foreign trade zones, #59 in Lincoln and #19 in Omaha.
- Werner Enterprises Inc. and Crete Carrier Corp.

- two of the nation's top
 trucking companies
 are headquartered in
 Nebraska.
- The state possesses an estimated 13,500 licensed motor carrier companies and 815,000 power units.
- Eighty-four public commercial and municipal airports serve Nebraska communities. Eleven commercial airlines serve ten airports in the state, providing direct service to both coasts.
- Six commercial service airports are located across the state.
- Two Class 1 railways, Union Pacific and

Burlington Northern Santa Fe (BNSF), serve more than 4,000 miles of track in the state. From its base of operations in Omaha, Union Pacific Railroad provides service spanning 32,000 route miles to 23 states across the western two-thirds of the country. BNSF's parent company, Berkshire Hathaway Inc., is a prominent fixture in Omaha, and the railroad maintains rail yards in Lincoln and Alliance, Nebraska, BNSF operates about 32,000 route miles in 28 states and two Canadian provinces.

Nebraska Advantage

The Nebraska Advantage incentives package enhances the state's business climate and makes it a preferred location for starting and growing business. The package emphasizes capital investment, innovation, job creation and provides training for workers who accept those jobs. Incentives include:

- Sales-only formula used to calculate corporate income tax liability
- No state property tax
- No inventory tax
- No personal property tax on intangibles
- 100% depreciation for personal property tax
- Sales tax exemptions
- Sales and use tax refunds on certain property

Business Costs & Climate

Corporate Income Tax

The Nebraska corporate income taxes are based on federal taxable income attributable to Nebraska operations. The 2012 tax rates are:

First \$100,000 of income	5.58%
Income greater than \$100,000	7.81%

Sales and Use Tax

The Nebraska sales and use tax is imposed on the sales transaction and collected by the retailer from the consumer. The state rate is 5.5%. Nebraska exempts capital equipment used in the manufacturing process from sales tax.

Personal Property Tax

Business inventories and certain classes of personal property are exempt from property taxation. Intangible property and household items are also exempt. Other classes of property exempt from taxation include: agricultural machinery, livestock, grain and seed, poultry, fish, honey bees, feed, fertilizer and farm inventory.

Unemployment Insurance Tax

The Nebraska unemployment insurance tax rate as percent of taxable wages is 3.23%. The average unemployment insurance tax per employee is \$288.

Utilities

Nebraska is the only state in the nation with electric service provided entirely by public utilities. The average total electricity cost per kWh is 13% below the U.S. average.

These public power systems control an efficient and dependable mix of generating systems that supply low-cost power for current and future needs. Nebraska's efficient statewide grid system with regional interconnections assures reliable services, adequate supply, and rates that are among the lowest in the nation for industrial, commercial, and residential users.

Nebraska's telecommunications companies were national leaders in adopting modern fiber optic and digital-switching technology. These companies provide Nebraska businesses with state-of-the-art telecommunications facilities. With one of the most advanced, competitive telecommunications environments in the world, Nebraska helps sustain United States Strategic Air Command, as well as many financial, information technology and customer service companies. The state is rich in dark and lit fiber. A vast network of multiple local carriers and numerous long haul carriers traverse the state along Interstate 80 and other essential transportation corridors in all directions. Nebraska's central locality is key to the connections these carriers make in Denver and Chicago, continuing on throughout the U.S. and around the world.

Nebraska Research and Development Advantage

The Nebraska Research and Development Advantage offers a state tax credit that may be utilized to increase research and development activities through partnerships with Nebraska businesses and state colleges and universities. Unique to Nebraska, is the ability of the business to receive a "refundable or cash credit." This suggests that a business may receive the cash refund without first establishing any earnings. The cash refund limits itself to the amount of state sales and use taxes paid, either directly or indirectly, by the taxpayer on the qualifying expenditures.
